Children by choice, not chance.

(Revenue \$) ORGANIZATIONAL SUPPORT TO MARIE STOPES INTERNATIONAL FOR EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES: In 2017, services provided by MSI prevented 8.2 million unintended pregnancies, saved 23,900 lives from maternal death, and prevented 5.4 million unsafe abortions by providing access to modern sexual and reproductive healthcare. MSI's work contributes to strengthening of the economies in the countries where we work, saving them an estimated \$438 million in additional healthcare costs. MSI reaches clients in locations where the need for reproductive health services is urgent and unmet by others; providing access to contraception and family planning services beyond the urban centers and out to the most rural and remote communities.

4b (Code:) (Expenses \$ 42,965,669. including grants of \$ 42,393,194.) (Revenue \$) MSI SUPPORT - EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES IN AFRICA: In 2017 MSI strengthened its impact in Africa, particularly in the Sahel, a region with high unmet need for contraception. MSI deployed 26 outreach teams, operated 9 centers, engaged more than 200 franchisees, and employed over 4,600 staff members in the region. MSI continued expansion of its newest service delivery channel in Africa, MS Ladies, which empowers midwives and nurses as entrepreneurs to deliver quality family planning services in their communities. Access to services continued to expand through the training of public and private providers. MSI also advocated for policy changes so that family planning services can be provided by a wider variety of trained service providers by allowing for the expansion of task-sharing in the

MSI programs include training and empowering maternal and reproductive health providers, and delivering onsite family planning programs and contraceptive services in factories where women work. MSI works with religious leaders and country staff to expand access to services in challenging environments, including Afghanistan, where MSI operated 12 clinics across 5 provinces.
