MSI services contributed to the economies of the countries in which we work by saving in excess of \$560 million in additional healthcare costs. MSI's medical teams travelled 12 million miles to give rural women and girls access to modern contraceptive methods. The contributions made through MSI United States helps the poorest and most vulnerable women and girls in some of the

MSI deployed 26 outreach teams, operated 9 centers, engaged more than 200 franchisees, and employed over 4,600 staff members in the region. MSI continued expansion of its newest service delivery channel in Africa, MS Ladies, which empowers midwives and nurses as entrepreneurs to deliver quality family planning services in their communities. Access to services continued to expand through the training of public and private providers. MSI also advocated for policy changes so that family planning services can be provided by a wider variety of trained service providers by allowing for the expansion of task-sharing in the

MSI works with religious leaders and country staff to expand access to services in challenging environments, including Afghanistan, where MSI continues operating 12 clinics across 5 provinces.
